

**APPLICATION FORM ONE-TIME COMPENSATION TAXI-, CAR RENTAL- AND TOUR COMPANIES
COVID-19**

Are you a registered car rental company, tourist tour company or are you a registered license holder for a taxi service? If so, then you are eligible for a one-time compensation of US\$ 100 per registered vehicle. To be eligible for this compensation, you must meet the following conditions:

For car rental companies and tourist tour companies:

- The company was established on Bonaire Caribbean Netherlands before March 1, 2020
- Copy of registration at the Chamber of Commerce Bonaire (not older than 6 months)
- Copy of identification document of the company's legal representative
- Copy of establishment permit (vestigingsvergunning)
- Proof of payment of the Motor Vehicle Tax (motorrijtuigenbelasting) 2020
- Car rental companies: proof of car rental tax payment 2020 and copy of the last 3 car rental tax payments in 2021

For taxi companies:

- Copy of registration at the Chamber of Commerce Bonaire (not older than 6 months)
- Proof of payment of the Motor Vehicle Tax (motorrijtuigenbelasting) 2020
- License holder of a taxi service: copy of the most recent driving permit and official approval
- copy of identification document of the legal license holder, being the main driver

This compensation is granted only once per company and per natural person who is also the permit holder for the taxi service. The Public Entity of Bonaire is responsible for the implementation of this scheme
